The Board of the Northwest Commission on Colleges and Universities (NWCCU) consists of up to twenty-six Commissioners, who are elected to staggered three-year terms and serve without compensation. A majority of the Commissioners are from institutions accredited by NWCCU, ensuring the diversity and geographical distribution of institutions. The Board includes at least one person from the region's Tribal Colleges, one-seventh (1/7th) represent the Public, and up to two persons employed by higher education institutions outside of NWCCU 's region and accredited by an agency recognized as an accreditor by the United States Department of Education.
